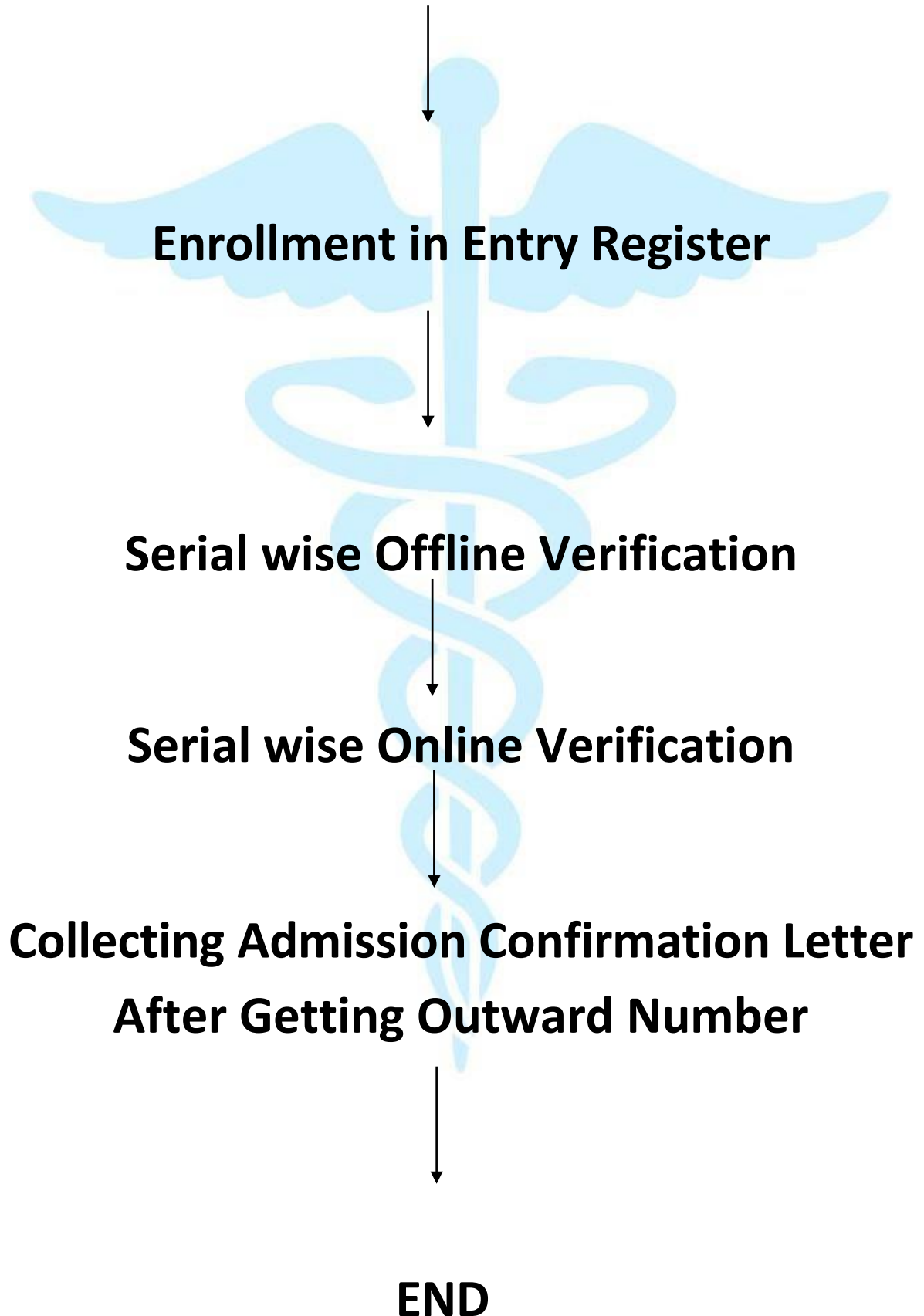

- i) **Domicile Certificate of the parent stating that he/she is domicile in the village declared as a Hilly area specified in the Table for the respective Regions** (Rest of Maharashtra/Vidarbha /Marathwada, as per the latest list issued by concerned Department) The said certificate should be obtained from the concerned Revenue Department officer (Tehsildar and Above).
- ii) To avail the benefit of HA claim, the candidate must have appeared at NEET UG -2026 examination.
- iii) The Competent Authority shall select the candidates claiming HA, on the basis of their Merit at NEET UG -2026 examination.
- iv) The constitutional reservation is provided under these HA claim seats.
- v) **The candidate should pass SSC/HSC (or equivalent) examination from School/Junior College situated in the hilly area of his/her parents domicile or if not so, at the most, from a School/Junior College situated in the taluka of his/her parent's domicile.**

1) DEFENCE CATEGORIES

- Def1 - For a son/daughter/spouse of an Ex-defence service personnel, domiciled in the state of Maharashtra.
- Def2 - For a son/daughter/spouse of Active defence service personnel domiciled in the state of Maharashtra.
- Def3 - For a son/daughter/spouse of Active defence service personnel, transferred to Maharashtra State from out-side Maharashtra, who is domicile of State other than Maharashtra.

2) For selection against Def-1 & Def-2 seats following conditions will apply;

- To be eligible for such a seat, a candidate must be a son/daughter/spouse of a person who has been a member of the Armed Forces of India and who has put in at least 5 years' active service and has been subject to Indian Army Act, Indian Navy Act or Indian Air Force Act; and includes an ex-serviceman who has retired from such service or was permanently disabled/killed in action. A candidate claiming a seat under Defence category will be required to produce a certificate from an Appropriate Authority, who is authorized to issue such certificate/Zilla Sainik Board in the State of Maharashtra certifying the same.
- However, the condition of minimum active service for five years will stand relaxed in case of Defence service person who has been permanently disabled or killed in action. The exception is admissible subject to production of a certificate from Zilla Sainik Board in the State of Maharashtra certifying permanent disability/death of such Defence Service person.
- To be eligible for seat in Def-1 & Def-2 category candidate should produce following certificates, i) Certificate mentioning that his / her parent who is/was defence personnel ii) Domicile certificate of the parent stating that he/she is domicile in the State of Maharashtra. The domicile certificate should be obtained from District Magistrate/Metropolitan Magistrate/ Addl. District Magistrate or Tehsildar.
- Candidates belonging Def-1 & Def-2 category shall be considered eligible for admission even if they have passed SSC and /or HSC examination from outside Maharashtra State.

3) For selection against Def.-3 category following conditions shall apply:-

- The concerned Defence Service person who is domicile of the State other than Maharashtra and who has been transferred in public interest to Maharashtra State, prior to the last date for filling up of Preference Form.
- The concerned Defence Service person ought to be working as on the last date of filling of Preference Form, at a place within the jurisdiction of the concerned regional area in Maharashtra in which the candidate is seeking a seat.
- The candidate ought to have appeared and passed the qualifying examination.
- The candidate is required to attach necessary and sufficient proof to fulfill above conditions and a certificate in proforma issued by appropriate authority who is authorized to issue such certificate.

No. MED 1021/C.R.128/21/Edu-2, dated 13th June 2022 (Annexure – Q), and any other G.R. issued in this regard from time to time), candidates joined against the seats of Government / Municipal Corporation colleges for admission to MBBS / BDS Courses either through GOI nominee, All India quota and State quota through NEET UG 2022 & onwards will be required to sign a social responsibility service to compulsorily serve the Government of Maharashtra or local self government or Defence services for a period of one year, after the completion of internship.

Additionally, he/she will be required to sign an undertaking to the effect that he/she will not leave India within a period of five years from the date of obtaining the degree, otherwise he/she will have to pay Non-Refundable Rs. 10,00,000/- (Rs. Ten lacs only) as penalty.

- 24.2 **Social Responsibility Service** for students passed from Government / Municipal Corporation medical colleges and **Private Unaided / Minority medical colleges**: As per Government Resolution G.R. No. MED 2026/C.R. 239/26/Edu -2 Dated 23/07/2026, the students who have passed MBBS from Government / Municipal Corporation medical colleges and **Private Unaided / Minority medical colleges** in the State of Maharashtra, there is NO one year social responsibility service.

25 PENALTY:

- 25.1 **PENALTY FOR LAPSE OF SEAT (MBBS/BDS COURSES)**: Any candidate responsible for lapse of MBBS/BDS seat at Government/Government Aided/Corporation Medical/Dental College will have to pay a Non-Refundable

penalty of Rs.10,00,000/- (Rupee Ten Lacs Only). This penalty is applicable to any candidate resigning a seat after the prescribed date for MBBS/BDS courses resulting in lapse of seat or also fails to complete the course, irrespective of admission quota of the candidate. This rule is applicable also to the candidates admitted under All India quota.

25.2 Penalty for Lapse of seat at Government/Government Aided/Private unaided College (BAMS,BHMS & BUMS): Any candidate who resigns a seat after prescribed date from Government/Government Aided/Private unaided College (BAMS,BHMS & BUMS) resulting in lapse of seat or also fails to complete the course, irrespective of admission quota of the candidate will have to pay Rs. 3,00,000/- (Rs. Three lakhs only) as penalty. This rule is applicable also to the candidates admitted under All India quota.

25.3 Penalty for Lapse of seat at Government/Government Aided/Private unaided College (BNYS, BPh, BTh, BASLP & BP & O Courses): Any candidate who resigns a seat after prescribed date from Government/Government Aided/Private unaided College (Allied Health Sciences courses) resulting in lapse of seat or also fails to complete the course, irrespective of admission quota of the candidate will have to pay Rs. 2,00,000/- (Rs. Two lakhs only) as penalty which will include 1st year tuition fees. If the candidate has paid the tuition fees to the institute, he/she will have to pay the difference amount only. If the candidate has not paid the tuition fees, he/she will have to pay Rs. 2,00,000/- (Rs. Two lakhs only).

25.4 However, Candidates who have paid a penalty as per clause 25.1, 25.2 and 25.3 before start of registration process for A.Y. 2026-27 shall be eligible for admission to A.Y. 2026-27

Above clauses will also be applicable to candidates who cancel their admission as per clause 22 of NEET UG 2026 Information Brochure.

26 CONDUCT AND DISCIPLINE:

26.1 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process.
